ORDINANCE AUTHORIZING THE SERVICE DIRECTOR TO APPLY FOR FAA AIRPORT IMPROVEMENT PROGRAM FY 2022 GRANT FUNDS, ADVERTISE FOR BIDS FOR AND ENTER INTO CONTRACT FOR REHABILITATE TAXIWAY (DESIGN PHASE) AND RECONSTRUCT TERMINAL APRON (DESIGN PHASE) AND DECLARING AN EMERGENCY AT THE MARION MUNICIPAL AIRPORT.

WHEREAS, The Marion Municipal Airport has developed and coordinated with the FAA, a project to address airfield concerns including pavement, lighting, and visual aids. This project includes the design for the rehabilitation of the Terminal Apron and Apron Taxiway pavement.

WHEREAS, The City of Marion may be eligible for FAA and ODOT Grant Funds and has been given the opportunity to apply for Fiscal year 2022 FAA Airports Improvement Program, which would become known as Project #30.

WHEREAS, 90% of total project grant funds are available through the Federal Aviation Administration, 5% of total project grant funds are available through Ohio Department of Transportation. City Council supports the application for any such grant funds.

BE IT ORDAINED by the Council of the City of Marion, Marion, County, Ohio:

Section 1. That the Service Director is hereby authorized to apply for FAA AIP Grant FY 2022 Grant Program, and if awarded, accept the Grant offer. Total Cost estimate of this project is \$85,000.00. FAA share is 90% or \$76,500.00, ODOT share is 5% or \$4,250.00 and City of Marion share is 5% or \$4250.00.

Section 2. That the Service Director is hereby authorized and directed to advertise for bids and enter into contract if bids received are less than the total estimate of the consultant and the funds are available. The Service Director is hereby authorized to enter into contract with the lowest and/or best bidder.

Section 3. The specifications for this project were prepared by Crawford, Murphy, and Tilly, Inc. of Columbus, Ohio, who was selected per FAA guidelines and authorized by Ordinance 2020-18.

Section 4. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this resolution were adopted in an open meeting of this Council, and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section 5. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the health, welfare and safety of the City of Marion and the inhabitants thereof, given the immediate need to make improvements and the deadlines involved in the grant process, and as such shall take effect and be in force immediately upon its passage and approval by the Mayor, provided it receives the affirmative vote of two-thirds of all members elected to Council; otherwise, it shall become effective from and after the earliest period allowed by law.
