(Chaffin) (Finance Committee, Mr. Daniels, Chair, 2-1)

Service Director Chaffin explained that this is a very similar procedure to the CARES Act. The City needs this in place as ARPA money starts being awarded.

Mrs. Fosnaugh made motion to add wording “and as approved and appropriated by City Council.” Feliciano 2nd.

In response to Mr. Ratliff, Mayor Schertzer explained that there are some situations where a timeline is so tight that it may be difficult to pull Council together. They really do not know right now. Chaffin explained that this ordinance does not appropriate anything, and it only allows us to apply and receive. The appropriation would be a separate piece of legislation. They are awaiting guidance and she expects that there will be a quick turn-around. With the CARES Act, they had some activities that required a turnaround as quick as three days. The bill was passed, and it was signed, and they were told that the money would be released, and the guidance would follow. Spending will come much later.

Mrs. Fosnaugh asked that the word “administer” could be removed, if her first proposal was not agreeable. Mayor explained that this helps city to ahead of the game and ready to go when the money is available. They have a lot of experience working with these types of grants – every term he has been in office. Chaffin added that any times you receive a grant, they do need to administer it to complete reporting, recording, and administering the program itself under the guidelines and rules established. They have to have an administer of the grant and it is included in the applications. Deciding what to spend it on comes much later. You must have an administrator to apply for the grant.

Mrs. Fosnaugh stated that she is uncomfortable with the wording because she believes this allows them to spend the money. She has spoken with several residents of the 5th ward and they were all in agreement with her. Mayor Schertzer said that they still have to come back for spec and bid before any money is spent.

Mr. Daniels stated that he thinks it is reasonable to ask that council have input on \$7 million. He thinks there would be some discussion and that could make for better results. He does not anticipate a time crunch, especially as Council can call special meetings. They have met a lot under less serious matters.

Mr. Ratliff said that he understands it is the appropriation process that comes after this. In the past, he feels like he has had input. He hates to change from processes that worked in round 1 and 2 for round 3, especially when the amount is much more than the last two. He is cautious about tying the hands of administration and is concerned that could get them in trouble.

OTHER BUSINESS

Mr. Feliciano asked about the licensing requirements for small minibikes and four wheelers. If they are on the street, Chief McDonald need to be licensed. Many of these vehicles do not qualify for licensing. He encourages people to report when they see it. They cannot ticket after the fact.

Mr. Ratliff, President pro tempore, announced that a select committee has been formed with the following members: Mr. Schaber (chair), Mr. Meade (vice chair), and Mr. Meade. This committee is an exploratory and investigative committee to look into issues within the Auditor's Office.

Christian Dunston (211 E. Fairground Street) asked about the change in traffic pattern between Church and Center. He does not believe that the right turn only lane is marked early enough. Mayor Schertzer explained that it had gone before City Council and was approved. They will be adding additional signage. It will also take the community a little time to get used to the change. Public Works Director Bischoff stated there would be additional lane markings soon. The fence was installed pre-1960. There are two cisterns in her yard. The fence was removed by the neighbor on 04/16. They have worked with Brent Roland and Malcolm Smith to determine the setback lines.

Charlie Esterline (518 E. Church Street) spoke on behalf of his mother Lee Esterline regarding an issue she is having with a fence. They are requesting some clarification on the alley. The fence was torn out on 04/16 by the neighbor.

Mayor Schertzer announced that 19 ton of tires were collected at the scrap tire event this past weekend. He thanked Sindy Thrapp with Love Your Neighborhood, as well as DKMM.

Chaffin announced an additional "Love Your Neighborhood" clean up later this week. Community Service workers have been helping with these clean ups.
