**Item 3. RES 2022-004: RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR TO APPLY TO THE MARION COUNTY COMMISSIONERS FOR MONIES DERIVED FROM THE AUTOMOBILE LICENSE TAX, AND DECLARING AN EMERGENCY** (added by Mayor due to deadline) (Bischoff)

Mayor explained that this resolution qualifies eighteen streets for improvements funded by the automobile license tax. It does not mean that all of those streets will be resurfaced. This tax produces about \$140,000 annually for the city and is part of a larger county award. There is a separate municipal tax. Depending on cost, they may only do one street off of the list.
